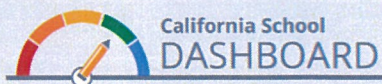

Eligibility for admission to the CSU is determined by three factors: (1) Specific high school courses, (2) Grades in specified courses and test scores, and (3) Graduation from high school. Some campuses have higher standards for particular majors or students who live outside the local campus area. Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. 2025-26 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Death Valley Unified held a public hearing on September 25, 2024, and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams VS. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. School Facility Conditions and Planned Improvements

Shoshone High (Cont.) was originally constructed in 1957 and is comprised of 1 classroom, a shared gymnasium, and computer lab.

Cleaning Process: The principal works with the custodian to ensure that the cleaning of the school is maintained to provide for a clean and safe school.

School Facility Conditions and Planned Improvements

Maintenance and Repair District maintenance staff ensures that necessary repairs keep the school in good repair. Highest priority is given emergency repairs.

Deferred Maintenance Budget: The district participates in the State School Deferred Maintenance Program, which provides matching funds on a dollar-for-dollar basis, to assist school districts with expenditures for major repair or replacement of existing school building components. Typically this include's roofing, plumbing, heating, electrical systems. interior or exterior painting, and floor systems.

For the 2023-24 school year the district allocated \$1,000 for deferred maintenance projects affecting Shoshone Continuation High School.

Safety of students and staff is a primary concern of Shoshone High (Cont.). The school is always in compliance with all laws, rules, and regulations pertaining to hazardous materials and state earthquake standards. The School Site Safety plan was last reviewed and updated on February 15, 2023 by the School Safety Committee and governing board.

All revisions were communicated to the both the classified and certificated staff. The school's disaster preparedness plan includes steps for ensuring student and staff safety during a disaster. Fire and disaster drills are conducted on a regular basis throughout the school year. Lock-down drills are held as needed.

Students are supervised before and after school by certificated staff and certificated staff during lunch. There is a designated area for student drop off and pick up. All visitors must check in with the office before visiting campus.
