#### 2022-23 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Death Valley Unified held a public hearing on September 13, 2022, and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams VS. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. #### **School Facility Conditions and Planned Improvements**

Shoshone Elementary was originally constructed in 1981 and is comprised of 2 classrooms. a shared gymnasium, and a playground.

Cleaning Process: The superintendent works with the custodian to ensure that the school is maintained in a clean and safe manner.

Maintenance and Repair: District maintenance staff ensures that the repairs necessary to keep the school in good repair. Work order are used to ensure efficient service and to give highest priority to emergency repairs.

Deferred Maintenance Budget: The district participates in the State School Deferred Maintenance Program, which provides matching funds on a dollar for dollar basis, to assist school districts with expenditures for major repair or replacement of existing school building components. Typically this includes roofing, plumbing, healing, electrical systems, interior or exterior painting, and floor systems. For the 2021 -2022 school year the district allocated \$3,500 to be spent for ongoing maintenance at Shoshone Elementary. This represents less than 5% of the district's general fund budget.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. #### **Professional Development**

Staff members build teaching skills and concepts by participating in many conferences and workshops throughout the year, then sharing their experiences and knowledge with district colleagues. The district dedicated 3 days to staff development annually for the past three years.
