Some campuses have higher standards for particular majors or students who live outside the local campus area. Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. 2025-26 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Death Valley Unified held a public hearing on September 25, 2024 and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and 10 take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. School Facility Conditions and Planned Improvements

Death Valley High Academy was originally constructed in 1957 and is comprised of 7 classrooms a gymnasium, a multipurpose room/cafeteria. a library/computer lab, athletic field.

Cleaning Process: The superintendent works with the custodial staff to ensure that the school is maintained in a clean an neat fashion. **Maintenance and Repair:** District maintenance staff ensures that the repairs necessary to keep the school in good repair are completed and work orders are addressed in a timely manner. Highest priority is given to emergency repairs. The items noted in the table have been corrected or are in the process of remediation.

Deferred Maintenance Budget: The district participates in the State School Deferred Maintenance Program, which provides matching funds on a dollar for dollar basis, to assist school districts with expenditures for repairs or replacement of existing building components. Typically this includes roofing, plumbing, heating, electrical systems, interior or exterior painting, and floor systems.

All HVAC systems are in good working order and are in place to help show energy savings per DVUSD's Proposition 39 energy conservation grant.
