**Personnel and Curriculum**

1. Hire Lisa Boutillier as a Shoshone Elementary teacher at Class 3, Step 7 of the Certificated Salary Schedule subject to verification of credential, units, experience and fingerprint clearance. Hire retroactive to August 1, 2021.
  
2. Hire Steve Belmares as an on-call Teacher’s Aide at Range 7, Step 4 of the Classified Salary Schedule. This assignment subject to change owing to pandemic concerns and mandates as well as student safety.

3. Hire Diannet Lujano as on-call Transportation/Teacher's Aide at Range 7, Step 4 of the Classified Salary Schedule. This assignment subject to change owing to pandemic concerns as well as student and staff safety.
4. Approve stipend for Paul Postle in recognition of responsibilities undertaken for the 2020-2021 school year into the 2021-2022 school year in the amount of \$6,000 to include services rendered as community liaison, remote meals coordinator, head of maintenance and operations, services coordinator, project planner and safety compliance officer.
